ALBERTA SIRES STAKES STANDARD BRED STALLION REGISTRATION ELIGIBILITY CONDITIONS

Only FOALS of 2013 conceived as a result of mating by an **ALBERTA STALLION** registered in the Alberta Sires Stakes Program will be eligible for nominations to the ALBERTA SIRES STAKES #34, to be raced as TWO-YEAR-OLDS in 2015, and THREE-YEAR-OLDS in 2016

FAILURE TO REGISTER THE STALLION BY JANUARY 1, 2012 (for \$250) or late registration by March 1, 2012 (for \$500) or advertised stud fee WILL RENDER HIS FOALS OF 2013 INELIGIBLE FOR NOMINATIONS

Effective January 1, 2008, STALLION OWNERSHIP and/or lease rights are not required to be held or controlled by an Alberta Resident. However the Stallion **must stand in Alberta** for the entire Breeding season in question.

GENERAL CONDITIONS

- (a) All applicants for stallion registration must submit with this form a fee of \$500.00 per stallion, payable to the **ALBERTA STANDARD BRED HORSE ASSOCIATION**. A clear photocopy of the stallion's Standardbred Canada registration certificate (front and back) or the actual certificate to be photocopied and returned to the sender is required for new and transferred stallions.
- (b) Stallion Owner(s)/Lessee(s) who violate the Stallion Registration conditions or the intent of the Stallion registration conditions may invalidate the Stallion's eligibility and maybe dealt with by Horse Racing Alberta, and/or ASHA.
- (c) Stallion eligibility to the ASHA Alberta Sire Stakes Program is subject to the requirements of ASHA policy memorandum BR-1 – 10/05, "Program Requirements for Stallions standing outside of the Northern hemisphere". (Available from ASHA)

Cheques that have not cleared the bank by the applicable deadline, and/or are subsequently dishonoured, will render the registration void and the stallion ineligible.

All Stallions Registered in the 2012 Alberta Sires Stakes Program by January 1, 2012 will be included in the Alberta Standardbred Horse Association Stallion Directory. There will be no additional costs to the Stallion Owner or Lessee for the Pedigree Page as it is included in the Registration Fee of \$500.00 per Stallion.
