- (a) All applicants for stallion registration must submit with this form a fee of \$250.00 per stallion, payable to the ALBERTA STANDARDBRED HORSE ASSOCIATION. A clear photocopy of the stallion's Standardbred Canada registration certificate (front and back), and/or verification of electronic registration or the actual certificate to be photocopied and returned to the sender is required for new and transferred stallions.
- (b) Stallion Owner(s)/Lessee(s) who violate the Stallion Registration conditions or the intent of the Stallion registration conditions may invalidate the Stallion's eligibility and may be dealt with by Horse Racing Alberta, and/or ASHA.
